5. NEW BUSINESS -

Assembly Bill 361 / Flexibility for Remote Open Meetings During a Proclaimed State Emergency – Recently enacted Assembly Bill 361, signed by Govern Newsom on September 16, 2021, provides local agencies with the ability to meet remotely during proclaimed state emergencies under modified Brown Act requirements, similar to the rules and procedures established by the Governor's Executive Orders.

Local agencies who wish to continue meeting remotely under modified Brown Act requirements, during a state of emergency, are required to adopt, by Resolution, authorization for remote teleconference meetings, consistent with Brown Act public meeting law and provisions of AB 361. Said action, by Resolution, will be active for a 30-day period at which time the legislative body will be required, by Resolution, to re-ratify the proclamation of a state of emergency and re-authorize remote teleconferencing meetings for the subsequent 30-day period to follow.
